Applications for the lottery will be accepted between January 6th through January 31st, 2025 for enrollment in the following school year. Following this open enrollment period, applications will be counted to determine whether any grade level has received more applications than availability. In the event that this happens, the Charter School will hold a public random drawing (or lottery) as needed at each learning center, or at the main charter office on February 3rd at 4:00 pm to determine admission for the impacted grade level, **with the exception of existing students, who are guaranteed admission in the following school year.** Admission preferences in the case of a public random drawing will be given to siblings of enrolled students. Please note, homeless and foster youth are not subject to the lottery process. In the event that a program is full, they move to the top of the waiting list regardless of the lottery results. Applications will still be accepted after the close of the window, but students will be subject to the waiting list if needed. At the conclusion of the public random drawing, parents notified of an immediate opening for their child must contact the school within two weeks of notification to be admitted to the school. Failure to contact the school will result in the spot being given to the next student on the priority list. All students who were not granted admission to the learning center of their choice due to capacity will be given the option to enroll in the school and then attend a nearby learning center if space is available, or they can put their name on a wait list according to their draw in the lottery. This wait list will allow students the option of enrollment in the case of an opening during the current school year. In no circumstance will a wait list carry over into the next school year.
